INTRODUCTION

Commissioner's Message

City of Poughkeepsie 2027-2031 CIP Overview

The 2027-2031 Capital Improvement Plan (CIP) is submitted to the Common Council to define funded and unfunded capital projects and expenditures in accordance with the City's Charter, Financial Procedures Article V, Section 5.01. Effective capital planning identifies the necessary upkeep and modernization of City infrastructure, capital equipment, and public buildings. Capital projects involve fixed assets that are essential to the economic and social well-being of any municipality (Bland, 2020). Capital projects are defined by the NY State Comptroller's capitalization guidelines as having a useful life of not less than five years and exceeding \$10,000.

Capital projects may involve improvements to infrastructure, public buildings, large equipment, or land acquisition. Capital improvements require substantial financial and human resources. According to the office of the New York State Comptroller (NYOSC), "numerous studies have pointed out that New York's local governments have been underfunding their capital needs over the last several decades" (OSC, 2016). Overcoming years of obsolescence and maintenance backlogs require near and long-term planning.

Capital Improvement Plans are a response to changing conditions. Therefore, in the near term, a robust CIP contributes to pride in citizenship and community. Longer-term planning improves the City's capacity to withstand economic and environmental shifts.

Capital projects are funded through direct appropriations or debt via the annual budget authority vested in the Common Council. The 2027-2031 Capital Improvement Plan identifies projects that are fully funded and critical items that are not currently funded. The inclusion of unfunded projects in the City's CIP emphasizes the magnitude of capital needs. The inclusion of unfunded projects informs the community about the extent of capital needs and helps decision makers prioritize what must be funded.

The primary goals of a capital planning process are:

- ensure city services are provided,
- coordinate capital needs with operating budgets to fund project debt, and seek other sources of aid such as federal and state grants, and
- keep the public informed about ongoing projects and future needs.

2027-2031 Capital Improvement Plan Highlights

The City of Poughkeepsie's 2027-2031 CIP contains projects that communicate the aspirations and potential of a city that values its citizens and environment. The 2027-2031 CIP identifies 51 projects valued at \$296.7M. This year's plan funds part or all of 16 projects at \$113.1M (38.1%) funded. In contrast, last year's plan contained 48 projects valued at \$226.2M, with \$39.5M (17.4%) funded. The 2027-2031 plan emphasizes the need for prioritization and project selection to position the City for successful delivery of services in an improving but inflationary environment. Water, sewer and lead line replacement projects comprise \$187M of the city's total deferred maintenance backlog. Water and sewer system modernization are important projects that impact the health and services of the citizens of the City. Additionally, other significant projects are fire apparatuses, other heavy equipment, investments in buildings, bridges, roadways and other infrastructure.

Conclusion

All projects in this CIP contain best estimates. The city is aggressively seeking grants and other aid. Further development of this CIP will benefit from continued coordination across city departments, guidance from elected officials, and citizen engagement.

Development of the City's 2027-2031 CIP was done in coordination with the Department of Public Works including Engineering, Development Department, Finance, City's Police, Fire, and Legal Departments and others. Strategic guidance for the development of the CIP was provided by the Offices of the Mayor and the City Administrator. On behalf of the Mayor and City Administrator, we look forward to insightful discourse to maximize gains in capital improvements throughout the city.

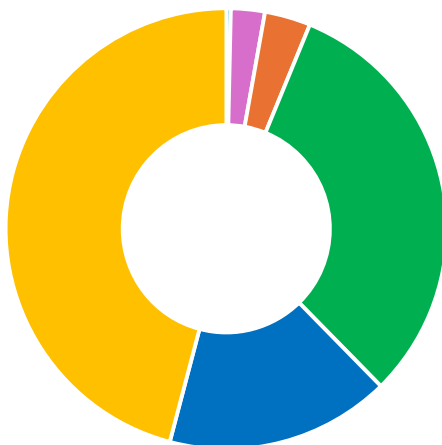

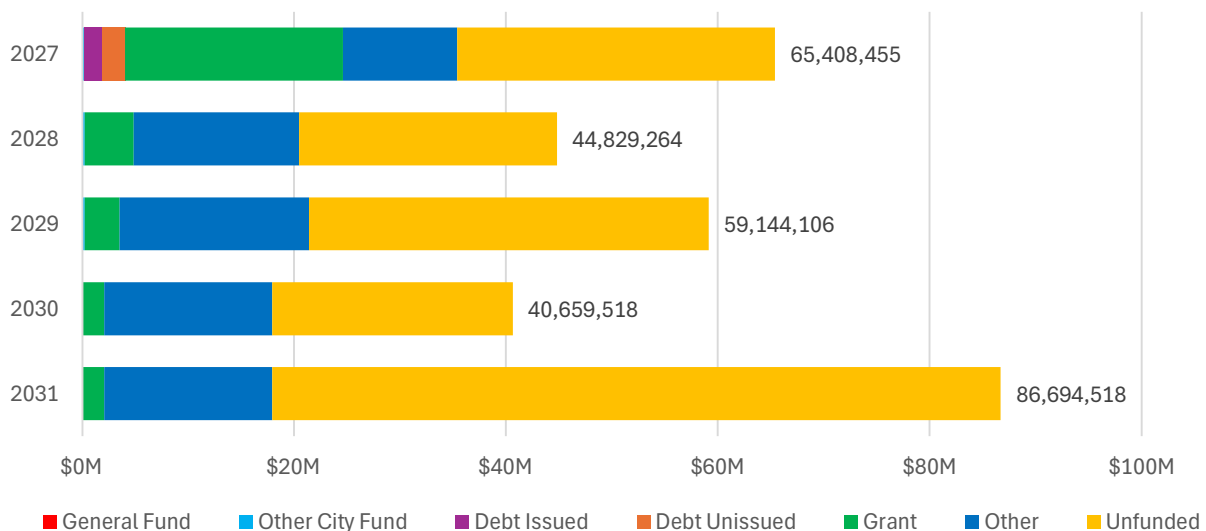

Phase 2 - Various Locations: Phase 2 of the project continues these improvements in other areas throughout the City that had been identified in the Comprehensive Plan and via other plans and initiatives. While currently unfunded, future funding sources could include the scattered sidewalks program (\$360k), and/or CDBG public infrastructure allocations in future years.

The City was awarded a NYS DOS planning grant (\$765k) in 2023 funding 85% of the Fall Kill Blueway Waterfront Design Guidelines project, to be completed in 2026-Q1 2028, which will inform future waterfront projects. This project implements several priorities included in the City Local Waterfront Revitalization Program approved by the Common Council in January of 2023, including Section IV Projects #2, 4, 10, 12, and 18, among others. The project will develop specific design strategies to address deteriorating flood and retaining Hudson River shoreline and Fall Kill wall conditions, mitigate flood risk, improve biodiversity and waterway health, and increase public space along the Hudson River waterfront and inland along the Fall Kill.

- Phase 1: Waryas Park Shoreline - The project will include the shoreline in the area of Waryas Park which has been undermined due to recurring tidal surges and repeated severe weather events. As such, several critical components of the existing shoreline reinforcement need to be fortified and/or replaced. Such items include various sizes and levels of stone along with several sections of concrete. Completion of this project will allow for a more seamless connection to the existing waterfront promenade located on either end of the park. Full connectivity is critical and has been incorporated into overall project cost. Estimated construction costs are projected to be in the area of \$4M, which will be updated as more accurate cost estimates are provided as part of the current Design Guidelines project.

- Phase 2: Fall Kill Locations - In addition to Waryas Park, the design phase of the current project also includes other inland locations adjacent to the Fall Kill at Dongan Square Park, Verrazzano Blvd., Brookside Ave., and the City-owned parking lot across the street from the Family Partnership Center on North Hamilton Street, for which funding for construction will be sought in future years.
